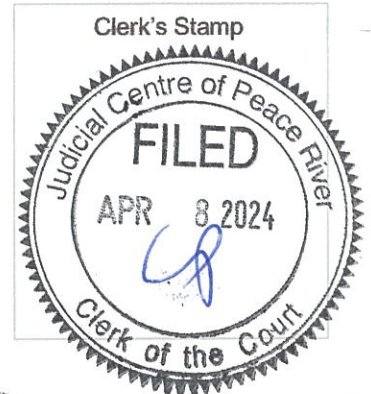

1. This Class Action Civil Suit: is to bring Awareness to the 'Active Genocide' in Canada & on a Global Scale. We as citizens of Canada & Others can no longer be 'SILENCED' for the crimes happening to us

unlawfully under, Government Entities and Officials. The Evidence contained within is to correct the miscarriage of 'JUSTICE' in Canada to: The Indian, (Respectfully in the words of my husband of Cree Decent, 'we are Indian's,' WCFN), the First People, (Indigenous), Inuit, Metis, those connected to their bloodlines and all-inclusive the Poor, Minority, Middle Class & Immigrants. There is 'ACTIVE GENOCIDE' AT THE HANDS OF THE CROWN, (Historically, the CHURCH & STATE), the CANADIAN GOVERNMENT, (FEDERAL, PROVINCIAL & MUNICIPAL), CHILD & FAMILY SERVICES, JUDICIARY, LAW ENFORCEMENT, MEDICAL, ALL INCLUSIVE INSTUTIONS WHICH INDOCTRINATE OUR CHILDREN & MAKE US SLAVES WITHOUT OUR CONSENT! Our Goal, is to IMPLEMENT a 'Global Wide Utopian Movement,' no one will be left behind. It is time to end the tyranny & live 'FREELY!' (Nancy O'Neill 2024) (AKA 'Is This Justice').

My Beautiful 'Nehiyow' (knee he oh), (to be pure), (the Western Cree), brothers and sisters. When I was a child, I remember saying, "when I grow up, I'm going to marry an 'Indian,' I did." He was very beautiful on the outside and broken within." You cannot see hidden Brain Trauma on someone's face. The continued impacts of applied sanctions from the Church & State, the (CROWN). We can correct this together, end the Unlawful Actions against the First Peoples and Others, in Canada & Globally. As a collective whole for the betterment of Humanity. We must UNITE GLOBALLY, all persons who share the ideals of upholding the Law to ensure complete FREEDOM & JUSTICE for All!

I, Nancy O'Neill of Peace River AB, am the author, owner & editor of this document. Our case presented here was moved forward on a CLOSED Investigation #990227. The actions taken against our family happened as our children returned to the 'Reserve' WCFN because of the school closures during Covid 19 Lockdowns & Mandates. Bringing awareness to these unseen crimes within

humanity, pushed and supported by government. This case comes with so many others and is our opportunity for Enlightening Society, Restoring Justice, Freedom, & Safety for Children and Families. Can you imagine that as you read these words, 'MILLIONS of children are going missing worldwide! We are living a Greek Tragedy! I stand by my words and all the documentation included, no one can go against me on this case. It contains their own Documents, there are 1000's of pages included. To bring awareness to the real FALSEHOODS of the Judiciary. I have included complaints and additional follow ups to the International Criminal Court and United Nations for 'Active Genocide in Northern AB & Across Canada.' Both Organizations still in 'Breach of Policy.' We must Unite Globally, help those in Need and End the Tyranny of Government!

### 'ACTIVE GENOCIDE'

#### In Northern Alberta & Across Canada.

Under Kee Tas Kee Now Tribal Council; All Inclusive KTC Child and Family Services the (Band Delegated) & KTC Education Authority (in Treaty 8 Territory) & (Across Canada). Modern Day Tribal Councils are the EXTENSIONS of the Federal Government. Every First Peoples residing within the Reserves are subject to HEINOUS CRIMES more so than any other, when they are born and raised into the (Reserves) of Canada & it continues to be (SILENCED)! (O'Neill 2024) (AKA 'Is this Justice').

*The Canadian Democracy is founded on 'The Rule of Law.' The expression 'law' means a set of rules that governs relationships of citizens with each other. It regulates commerce and protects people from the unlawful acts against their person within a community and protects people from unlawful acts by individuals and or the State.*

*There are certain key principles contained in the 'Rule of Law,' including:*

- 1. The government enacts law in an open and transparent manner.*

2. The law is clear and known, and it is applied equally to everyone.
3. The law will govern the actions of Government, private persons, and their relationship to each other.
4. The courts will apply the law INDEPENDANTLY of POLITICAL and OUTSIDE INFLUENCE. (Canadian Government)

**For the Readers of this court document, if you come across similar statements. There is lots of information pulled from dozens of my writings over the last 3.9 yrs. (24 years living and working inside the Reserves of Canada). The importance of the information is to show the severity of the CRIMES that were committed against our children & family and what continues today against millions of others in Canada and Billions Across the Globe. (O'Neill 2024) (AKA 'Is this Justice'). (The systems must be exposed).**

**This is my Amended filing of Court Docket # 2409 00032, Dated Feb. 27<sup>th</sup> 2024. What I have learned recently is the font is now size 9, smaller and harder to read. I did remove the grey boxes otherwise all the important information at the top would be really hard to view. (There is an implied misconception, leading people to believe they can 'Self Represent,' Fairly and Equitably.**

**'THE HIDDEN CRIMES OF CANADA, NO ONE IS SAFE. WE ARE SILENCED, THE UNJUST GOING FULL FORCE TODAY, EMBEDDED WITHIN THE INSTITUTIONS. THE CRIMES AGAINST CHILDREN AND FAMILIES, THE SANCTIONS ARE WHAT CONTINUE TO CREATE, ANXIETY, GRIEF, LOSS, SUICIDE, PTSD, CONFUSSION, DYSPHORIA, DEPRESSION & SUBSTANCE ABUSE. ALL GOVERNMENT INDUCED THROUGH THE SYSTEMS AND UPHELD BY THE JUDICIARY. IT IS HAPPENING, ILLEGAL APPREHENSIONS BY THE CHILD & FAMILY SERVICES. THIS IS WHERE THE ACTIONS STARTS FOR HUNDREDS OF THOUSANDS. (THE FIRST PEOPLE ARE THE MOST IMPACTED & ARE CONTROLLED WITHIN THE RESERVES). THE FALSE ACCUSATIONS BY LAW ENFORCEMENT, THE CROWN & MEDICAL ESTABLISHMENTS CREATE THE CONTINUANCE OF RAPE, MURDER, PROSTITUTION, MOLESTATION,**

CHILD PORNOGRAPHY & SEX TRAFFICING. THE FIRST PEOPLES (INDIANS), ARE THE MOST SUSCEPTIBLE AFTER THE HORROR OF COLONIZATION, RESIDENTIAL SCHOOLS & THE 60 SCOOP. THE GENOCIDE CONTINUES! YOUNG CHILDREN ARE BEING FORCED INTO BODY MUTILATION, HORMONE MANIPULATION, MISLED VACCINATIONS, (THE COVID 19 GENOCIDE). (THIS IS HAPPENING CANADA WIDE AND ON A GLOBAL SCALE)! CHILDREN & OTHERS, PARENTS HAVE NO RIGHTS OR SAY. OUR FREEDOMS ARE BEING STOLEN AT A RAPID RATE. THERE ARE NO SANCTIONS FOR PEDOPHILES IN CANADA & IT IS SPREADING ACROSS THE GLOBE. NO ONE IS UPHOLDING THE CONSTITUTION. (DEMOCRACY IS A LIE, THE COURTS ARE NOT IN PLACE FOR THE COMMON MAN ONLY TO UPHOLD THE CORPORATION & THE CONTRACTS FOR STAKEHOLDERS. WE ARE UNDER SOCIALISM WITH A PRIME MINISTER WHO IS BECOMING A DICTATOR! NO CANADIAN HAS SIGNED FOR THE MISTREATMENT, LIES & MANIPULATION UNDER THE CHURCH & STATE, THE POPE, THE PRESENT & (PAST) CROWN WITH AFFILIATES, AND ITS INSTITUTIONS!' THE ELITES AND THE OUTSIDE ENTITIES WHICH ARE EXTENSION OF GOVERNMENT, ARE ALL CONNECTED BY LIES, GREED AND DECEPTION TO HUMANITY. OUR VERY EVOLUTION WAS CORRUPTED FORM THE VERY BEGINNING!

*There are 6 areas of Law contained within the Schedule 1. Family, Civil, Criminal, Constitutional, Severance and Human Rights Violations. Over the last 3.9 years I have discovered and heavily documented that it is impossible to get the real truth out)! 5 areas of law are filed within the courts of Peace River, High Prairie, Grande Prairie & Edmonton AB. THE ONLY WAY THEY COULD MOVE AGAINST OUR FAMILY WAS 'ILLEGALLY' WE WERE FORCED TO BE CRIMINALS ON A CLOSED INVESTIGATION # 990227. JUDGE CLAUS KARL WILLI THIETKE WOULD NOT ALLOW FOR ME (US) TO PROCEED ANY OTHER WAY IN HIS COURTROOM. NEVER ANY INVOLVEMENT WITH THE CHILD AND FAMILY SERVICES THROUGHOUT MY BLOODLINE. MY CHILDREN ILLEGALLY APPREHENDED BY A BAND DELEGATED CHILD & FAMILY SERVICES BECAUSE THEY CAME BACK TO THE RESERVE WITH THE USE OF COVID 19 LOCKDOWNS, MANDATES AND A PLAN IN MOTION FOR 1 YEAR. I, NANCY O'NEILL RUNNING CADOTTE LAKE SCHOOL ALONE, ON SITE DURING THE*

CLOSURES. WE WERE FALSELY MADE CRIMINALS & TOLD IN ALL DIRECTIONS, 'DO NOT SHOW ANY EMOTION IN THE COURTROOM.' STANDARD PRACTICE IN THE COURTS OF CANADA! THE GREATEST SYSTEM OF UNJUST TO HUMANITY.

'Canada's legal system is based on the English and French systems. Explorers and colonists brought these systems to Canada in the 17th and 18th centuries. After the Battle of Quebec in 1759, the country fell under English common law, except for Quebec, which follows civil law.' (Government of Canada). This shows how Archaic the Systems truly are, we did not sign for this and cannot continue to follow it. (N. O'Neill 2024) (AKA 'Is this Justice').

There is no way in Canada to have a fair, Legal, Just Court Proceeding and or Appeal. Prior to Trial the Rules of Court are broken, all legal processes and timelines ALTERED to suit the side for the CROWN. If you are a Self-Representative you will be terrorized within the Court & it's Systems! An Appeals Judge never sees the real facts, they are removed in a Mini Voir Dire. A Mini Trial before the real trial proceedings, this allows for the judge to remove all your defense. The very reason you are in court, illegally. The court clerks are trained to alter the transcripts as we are all watching. There will be all kinds of audio difficulty, and in our case the Judge refused to go back to any sections I requested. This was only allowed for the Crown Prosecutor, (5 can be named in our case). Everyone is connected and helping each other to make you look guilty. There is no Cross Referencing of Criminal Law with Family or other Areas. This is how they falsely Apprehend the children in the First Nations and Other. You are placed in the Criminal Court, illegally because they paint you as an unfit Parent in the family court. The Family Court starts many proceedings within the Judiciary and pulls in Billions of Dollars of the heads of INNOCENT CHILDREN & FAMILIES. (O'Neill 2024) (AKA 'Is this Justice').

**2. The (our) Case of Peace River CROWN vs. O'Neill/Thomas 2020/2024, which was completely FABRICATED, and moved forward Illegally on a closed Investigation # 990227. The Illegal Apprehension of our 5 children would take place one month later. Our children had to returned to Woodland Cree First Nation the end of March 2020, because of the Covid 19 lockdowns and mandates. Our children reside in Peace River, AB with myself, Nancy**

O'Neill (mother) and my oldest son Nolan Paul, full time since 2016. Nolan has attended Peace River schools since grade 3. KTC CFS removed everyone from our lives as if we had no family or friends, myself, a huge part of the community (WCFN) and Ernie Thomas, Common Law husband, a 'Knowledge Keeper,' were Falsely turned into Criminals, on the words of real Criminals. Lynn Thomas, Ernie's Bio., sister and Arlene Courtorielle, both 150 yrs. Plus Generational Traumas. Arlene C. 3rd. Gen. UTERO EXPOSURE UNKNOWN. (Both with Criminal Records, well known in the courts & with Child and Family Services, on and off the Reserve).

Parents in the Reserves (First Nations) of Canada will lose their children at a higher rate than any other. All systems uphold the ARCHAIC PRACTICES of the RESIDENTIAL SCHOOLS. Our case is orchestrated on DOUBLE Investigations, Dockets & Complaint Numbers,' ILLEGAL under the Constitution. There was 18 Charter Breaches, (Infringements) against Ernie Thomas, our family and my person in 2.4 yrs. (I Filed this on Sept. 9th 2022 and Illegally Quashed Sept. 12th., by Judge Ambrose, so the Trial Judge Thietke would not have to touch it in (PR AB). This corruption could only move forward ILLEGALLY. There was a 'PLAN 'in motion for 1 year, very clearly laid out in my findings. This was admitted by Lynn Thomas to her Father William Thomas (June 10<sup>th</sup> 2020 as she was ARRESTED that day on Breach of a different Warrant) at (WCFN). Lynn made the 911 call on June 6<sup>th</sup> 2020 and it was CLOSED & DEEMED MALICIOUS the next day June 7<sup>th</sup> 2020, by Officer Shin Kim (PR RCMP).

3. There are two Investigations # 990227 The true investigation number for Ernie Thomas and Nancy O'Neill Opened June 6<sup>th</sup> & Closed June 7<sup>th</sup> 2020, DEEMED MALICIOUS & (SILENCED in the Courts). This investigation number #997225 was placed 6 pages in the KTC CFS disclosure. Not provided for over 5 months until after the ILLEGAL APPREHENSION of Ernie Thomas's Bio Child Penelope Thomas with no exchange of paperwork and our 4 Biological children 2 days later. There is one document to show the date of the Illegal Apprehension, dated July 9<sup>th</sup> 2020. This was provided Dec. 2020. In the (CICIO RECORD PACKAGE SUMMARY). The author of this document, possibly there are several,

committed **FRAUD and TAMPERING WITH EVIDENCE**. 100% verifiable, the documents speak for themselves. All Crimes committed in this case against our family are punishable by incarceration. Simply because these individuals are shuffled around does not excuse their Crimes against my family and others. This is Common Practice for all Illegal Activity under the CROWN.

The 'Act of Genocide' is Punishable by 5 years of (Immediate) Incarceration. The Pope 266th is (the strongest entity on earth and the push and drive for all Wars & Crimes against Humanity. Pedophilia comes from not allowing the Priest, Nuns & Bishops to marry within their Vows). (The Roman Empire, brought young men into adulthood by sodomizing them. This is one reason Rome fell, along with Internal Corruption). Our present society has evolved on the TYRANNY, GREED, CONQUERING THE ESTABLISHMENT OF THE COURTS, ALL TO BLIND, MISLEAD, REDIRECT MANKIND. TO BE SLAVES TO THE CHURCH & THE STATE, FOR THEM TO CONTROL AND RULE OVER US! (IT'S THEATER, WE ARE PAYING FOR THEM TO ACT AND THEY 'SUCK' AT IT). Having Belief and Religion IS A GOOD THING BUT the Manipulation and control is UNACCEPTABLE. The entire Canadian Government Under the House of Commons, Judiciary, Law Enforcement, the Medical (is playing a massive role in the control over our lives, as is the use of War & Military to instill 'FEAR' in us).

### **Related Dockets:**

**High Prairie Provincial Court: CP024000440/CP024000441-** Penelope (AKA) Penny Thomas was removed from our family (July 7th one month after our investigation #990227 was CLOSED), and placed back with her Bio mother Arlene Courtorielle. (Arlene with 3rd Generation UTERO Exposure Unknown, Heavy Drug Addictions with other substances, her medical records do not lie). Penny AKA (Penelope Thomas) was Fully Diagnosed Nov. 5th, 2014 (with Multiple Brain Trauma). This is **silenced** in the Courts of High Prairie and Peace River, AB (ILLEGAL). All of these court Jurisdiction that have been involved with this case have had Court Clerks & others, Tampering with Evidence, Committing Fraudulent Activities, Illegal use of their Position, (SOCIAL CONTROL) with respect to the maintenance of Court files and Filings



in HP, PR, GP, EDM. (100% verifiable in my findings), (N. O'Neill, 2024) (AKA 'Is this Justice').

Our 4 children were never in the courts for any reason, their Docket number CP024000441, it was hand written on the Docket Faxed Filed July 14, 2020. The Court for our children took place 7 days after they were ILLEGALLY APPREHENDED July 16<sup>th</sup> 2020. We were Never separated from our children ever, especially me a mother for now 24 years and 25 in Education. Our children were hidden for 12 days in Loon Lake AB, (Common Practice for KTC CFS). I was breastfeeding my youngest child, Lawrence. The Child and Family Services 'IMMEDIATELY' try to sever the bonds between the mother and child. It creates immense suffering, pain, and confusion. The longer the separation the more trauma is imposed causing a life filled with uncertainty, blame & confusion. Hundreds of thousands of Indian families & (Others), are suffering this each year in Canada. Upheld by the RCMP, they will lay a 'No Contact Order,' as soon as they can work it into the courts (Standard Practice on the reserve). There will be no movement of the children until this is in place. This is happening illegally to families all over Canada, to 'TORTURE' the families. The Child and Family Services want the children at young ages, then these individuals will fill the hospitals, jails, institutions and it is business for Stakeholders. They think the more broken the better, it will bring more \$\$\$\$\$\$. Thus, creating clientele for these corrupt institutions and the people's entire lives.

On March 10th 2021 in High Prairie AB, there was a false hearing set for our 4 children O'Neill/Thomas. The Honorable Judge Chrenek did make me believe she signed my children off PGO and no one on their side knew the date they Illegally Apprehended our children. I was not allowed to enter the courtroom. I sat outside in my truck unable to give any documents to the Judge as usual. The Last sitting with Judge Chrenek, she was nice. March 10th, 2021 those present on the call, Advocate Lawyer Natalia Reiman, (Grande Peace Law). Judge Chrenek asked Natalia Reiman about our children's time in care, Ms. Reiman said, "oh the little one is getting close to 'time in care,'" Judge Chrenek replied, "you want them, you can have them all PGO," referring to KTC CFS. My goodness who would ever want to torture people like this

**with their children. It's all a game, and they are the kings & Queens, we are soon to become the poorest peasants if we don't stand up for JUSTICE! I will never forget Ross Brooks the Director's Lawyer he's, 'Evil.' He should serve 100 life sentences along with any other Lawyer for a Director and all Judges upholding the lies.**

**(Both courts are utilized to drain the families through two litigations, making parents criminals and forcing them to obtain separate lawyers who follow the corruption only). The tactics and abuses create high levels of anxiety, PTSD & terrible TRAUMA. All Imposed and Implied by the Child and Family Band Delegated, RCMP, the CROWN, the Family & Criminal Courts, the Medical, (Psychologists & Others). The Government, Federal/ Provincial, Ministers with total (Neglect and Ignorance). Not one level of Government or Court is held accountable for their Laws and or Policy governance. The Judicial only upholds the corruption, clearly prior to 2020 and full force during Covid 19 Lockdowns, Closures and Mandates. We have been very misled by the Court systems, government, law enforcement and others in Canada. This old Archaic system must be replaced. Its very foundation was built on FALSEHOODS, Tyranny, Lies, Control, Fear, Murder, Rape, Implied Privilege because of a person's blood line. The Suffering continuing under the Greatest Theatre of all times. (The 'CONTROL' by a 1% of the Population).**

**The CFS took the place of Residential Schools and they are used to generate BILLIONS of dollars, as they drive all the systems including the COURTS. (The Family & Criminal Court are main stakeholders with CFS). THE SO CALLED 'FOUNDING FATHERS HAD IT WRONG' HENCE THE MASSIVE BREAKDOWN IN SOCIETY TODAY. The Creation of CFS, only with 'Evil,' corrupt intentions. This is how they legally traffic children in many ways. Once you have a Birth Certificate you are OWNED by the CROWN. (When Indian children & others enter the system, they become broken for life. (On the Reserve, everyone becomes easy prey). The Government assigns us numbers in many ways, it is to track us. It becomes a contract and it will last for 99 yrs. The contract will outlive you and it will follow your children forever. Hence the 'Indian Status Card, Health Care, Birth Certificate - all contracts. (Residential Schools, the 60 Scoop, Present Day & hidden within the systems).**

The families on and off of the Reserves, (Indian and Other) will continue to live under Section 12 of the Charter of Rights and Freedoms. As parents, we were made to proceed as criminals in the Provincial Court of Peace River (Section 11 Under the Charter of rights and Freedoms). In High Prairie, AB (where they initially remove the children and start the Action). (This is Common Practice like in the Residential **Schools and** going full force. The **DELEGATED** caseworkers never help the families attend court. So, if a parent is absent the 'Delegated or non-Delegated Caseworker' will lie and 1000's of Indian (Indigenous) children are lost each year, never to be seen again. (This pertains to the poor, minority, middle class, and immigrants. Covid 19, was definitely used as a tool to Apprehend more children and so were the fires. (Don't forget Maui or all the Government Arson in Canada, FEAR and FORCED DISPLACEMENT). Thousands of (Indian) Indigenous & Others forced into their town and Cities. On a Global scale the governments and institutions are responsible for hundreds of thousands of women and children to be raped, murdered, missing all innocent and nowhere to hide. (The Global GENOCIDE), (Covid 19) & (induced War in other countries).

**2008187448P1/200818672P1: PR CROWN made us Criminals against our Children and Accusers.** Officer Cst. Michelle Phillips was (being rewarded) and moving into a Crp. position the same time she was terrorizing our family on a CLOSED Investigation # 990227. (Standard procedure, reward the CRIMINALS within their Public Servant position for creating PAIN, SUFFERING AND HAVOC. (This is how RCMP operate and receive bonuses especially from Child & Family Services). An 'INFORMANT' was used to sign three months after the 911 call was CLOSED and DEEMED Malicious. (Aug. 21<sup>st</sup> 2020) & 2 months after they already ILLEGALLY APPREHENDED Penny and our 4 children on a closed investigation number. 'Dyanna Powers' of PR AB, unknown to the family and paid or promised early dismissal perhaps by the PR CROWN and/or PR RCMP, an Officer used to sign and cover for their corruption. At the time in Peace River, Arlene already broke every law and or rule put in place, utilizing meth with Penny back in her so-called Parenting Time. (Heavily Documented in the Affidavit of Circumstances of Arlene Courtorielle, the Docket ending in#126, a fake Docket and the docket ending

in #124, this Docket was used to clean things up and remove Ernie Thomas and myself (Nancy O'Neill) from Penny's life like we didn't exist. Bullying us to sign her and our own children over. We would never sign away our children. It can be historically proven hundreds of thousands of children have been Illegally STOLEN in Canada since Colonization has begun & Millions worldwide.

**FF028000536- Ernie signed papers for Penny, June 15th and he was asked to write a letter giving up his 'Parenting Time' for Penelope by Delegated Caseworker Tiffany Letender KTC CFS. She terrorized us for the entire month, helped with the Illegal Apprehension and then was removed so she could be protected for here crimes. Daughter In Law to Artur Noskey (Grand Chief of Treaty 8). (We had no idea where our children were and it was 6 days into the Illegal Apprehension, complete HORROR).** This is standard procedure, shuffle people around in positions and always protect their workers who will commit crimes for bonuses. (STEALING CHILDREN, HELPING TO BREAK THE FAMILY WITH ILLEGAL APPREHENSIONS AND DOZENS OF CRIMES CONTINUING AGAIST THE INNOCENT. Living under Section 12 of the Constitution. After the Forced Removal of Penny July 7<sup>th</sup> 2020, the Band Delegated would not stop to trying to make it look like we were CRIMINALS, And that were unfit to raise any children. (Never in our lives). When the Bio Mother Arlene Courtorielle with (3rd Gen. UTERO Exposure UNKNOWN and 150 yrs. plus of Imposed, Implied Generational Trauma. Her partner Lynn Thomas with (multiple Arrests), both heavily documented criminals with heavy SUBSTANCE ABUSE). Arlene Courtorielle, is a pro in the Child Welfare System, she has 30 occurrences with CFS since 1998 all recorded in the Affidavit of Circumstances ending #126 & the cover up docket #124 (Dec. 2020). These documents were provided by CFS in Peace River AB, (Caseworker Arjoo Khan, she is on all the documents from PR CFS dealing with Arlene Courtorielle. 100% a part of the tampered documents. With the CFS or the courts under Rule 9.42C does allows for anyone to sign for a Supervisor, Director and or a Judge. In these positions no one should be signing for them ever, (PURE CORRUPTION). They will intentionally not file Documents, Orders or Undertakings unless it suits their Narrative. On Oct. 8th

2021, Judge Marceau of PR was out Court Jurisdiction for the second time, (prior was on Feb. 26th 2021). Judge Marceau, was scared of me. Through the phone proceeding for a Private Guardianship Order, he did call me by Ms. O'Neill, and was willing to remove everything but one allegation from myself and Mr. Thomas. Once he called me Nancy and immediately apologized and said, "Ms. O'Neill I am here to make you as comfortable as possible for you." I had reported on him and many of his colleagues to the 'Department of Justice.' The women at the PR Courthouse refused to update the court file and kept me (Nancy O'Neill) as the worst criminal on Docket for over 2.6 years & the Judges were upholding it, Illegally.

**CP028000126 FAKE DOCKET/ Affidavit of Court Circumstances PR CFS (Arlene Courtorielle - 30 occurrences with CFS in multiple areas).**

**CP02000124 (The cover up Docket) (It was introduced in the late winter of 2022, before Penny was signed off PGO with her other 2 sisters August 25, 2022). This docket removes Ernie Thomas the Bio Father and Nancy O'Neill from Penny's life. We raised her for ten years and it took 5 to get her full Medical Diagnosis of Generational and UTERO Induced Traumas. Without that full diagnosis and medication to calm her, Penny could never be used against us, as part of the 'PLAN.' 100% verifiable in my findings and medically supported stemming from Birth & (UTERO EXPOSURE UNKNOWN).**

**Court of Queen's Bench - Civil - Docket # 2209 00038 Filed (April 28th, 2022) by Me, Nancy O'Neill Against: Queen Elizabeth the II, 449 members under the house of Commons, all levels of RCMP, Judges, Lawyers, the list was extensive and included further in this document. Note No 7 (2011 ABQB 408) was Illegally Quashed June 10<sup>th</sup> 2022. Without a Judge ever to see the contents or 101 documents sent in support of my findings. The Provincial courts tampered with documents and many others; the corruption runs deep. (There are Forged and photocopied, signatures of Justice K. G. Neilson, EDM AB). At the GP Courthouse I filed the document, they made a copy, reviewed it, then refunded my money (Feb. 28<sup>th</sup> 2022). I was sent me back to PR Court Clerk Shelly Shmudt, who, helped to move these illegal actions forward. With the help of a lawyer in the Justice Department**

Kathryn Starks and a Lawyer (Taryn Burnette of Gowling WFL), representing Troy Jasen from the (Alberta College of Psychologists, & Lloyd Flaro a (Psychologist utilized by KTC CFS & Edmonton CFS). Sgt. David Brown PR RCMP provided his docket that I mailed him Registered mail. Not the Docket sent to Queen Elizabeth the II it (was ILLEGALLY QUASHED June 10<sup>th</sup> 2022).

The Civil Suit was to bring awareness to my findings of 'ACTIVE GENOCIDE' in Canada under a Giant Tribal Council & all Services including (KTC CFS & KTCEA). My past employer of 5 years as a Counsellor and Inclusive Ed. Coordinator. I was always the Lead in many roles in Cadotte Lake School. The continuance of crimes against Indian, the (First People) my family and all others in Canada is under the control of THE CROWN, (Church & State, the Historical contexts still apply) and its systems are (Silenced in Canada). The same practices of so-called Colonization never left. Very well hidden and embedded in the institutions.

**'The Crown vs. O'Neill/Thomas 2020-2024. Our Charter Application: contains 18 Charter Infringements in 2.4 yrs. The Illegal Crimes against our family, is in accordance with the Charter of Rights and Freedoms embedded in the Canadian Constitution. (Filed Sept. 9th, 2022) s. 2(b)(d), s. 6(1) (2)(a)(b), s. 7, 10(a)(b), s. 11(a)(d)(f), s. 12, s. 15, s. 24(1), s. 24(2), s. 25, s.52(1) 52(2). This was Illegally Quashed, Sept. 12<sup>th</sup> 2022 by Judge Ambrose, so the Trial Judge Thietke, wouldn't have to touch it. They move quickly to remove the truths in the court. (One Charter Infringement makes a case null and void), (Silenced at all costs) & (Unconstitutional).**

I was made to sit all day as usual; they would try to tire me out and confuse me before having me Self Represent for our Family. The court had to be set for me as always. The court room would be empty by then, myself, alone standing against 3 or more men in a closed setting where I was always bullied. Every due process was taken from us during the proceedings of the courts. They would not remove lawyers even though I had let them go. This way they could still manipulate the court sittings. One lawyer after the next would take our

money, ignore, bully and or stall us. So, I fired them all! There would be no movement for our family in any court until I did.

The first provided RCMP #2021-4237 our real number, & 2 yrs.. after the fact they put this number into our file #2021-3027. 100% verifiable within my findings. Illegal activity, I have 6 letters of correspondences to verify our initial file #2021 - 4237. This second number came from Civilian Review and Complaints and all systems help support each other with the corruption. We are paying for this; Canadians and we don't even see it. All Institutions of high defense, National Security, CISI, any Complaint department, they are used to stall, defer us from moving forward and will not give you a straight answer until you are finished in the courts. It is in their Policy; you can look it up. The Civilian Review and Complaints (controlled by the Federal Government and the only governing body for the RCMP). They will never go after one of their own, all systems set to protect them and falsely incriminate others. A perfect example is the "Coutts Boy,' 2 of the 4 are still, ILLEGALLY INCARCERATED. The jails are part of the meal ticket, billions of dollars each year and are run on contracts with stakeholders (O'Neill, 2024) (AKA 'Is this Justice').

My first initial complaint to the Commander of K Division May 18th 2021 & the first complaint to Civilian Review and Complaints for the RCMP (May 18th 2021). The Email correspondence from Art Hopkins a Reservist with the RCMP of 43 yrs. Our first contact was March 16th 2022. All they were in breach of policy for 9months. (SGT. David Brown of the PR RCMP, the Commander of K Division (Curtis Zublocki), the Civilian Review and Complaints & Art Hopkins a Reservist of 43 yrs. RCMP). My Interview with Reservist Art Hopkins took place March 22nd, 2022. And my first letter of correspondence from SGT. Dave Brown PR RCMP, #2021-4237 was dated March 23, 2022. The Civilian Review and Complaints tried diligently to have me accept a new number #2021-3027. This is how they control everything. The RCMP, Reporting Agencies will take your information, doctor it to fit their Narrative and won't release it until after your trial or court proceedings are finished.

You must print all correspondence once you first open it. By the second review the documents will be corrupted and un comparable what a clever use of 'Taxpayers money.' I found this in multiple complaint departments. (No one is upholding Justice within CROWN and other Agencies). When they say 'CONFIDENTIAL,' it means CRIMINAL. This is Illegal Practices under the very governing bodies within SOCIETY, (Social control and side blinding the public with Acts, Laws, Charters, as civilians we have no real protection. The ones in Positions of Power are never held Accountable for any of their Heinous Crimes ever. This is not UPHOLDING the 'Rule of Law.'

I have dozens of correspondences covering and masking the complaints I have made. All to protect the corruption, ILLEGAL and totally UNCONSTITUTIONAL. I will not stop looking for ways to expose these crimes against Canadians and others. They are in breach of Policy and Immediate 'ACTION' must be taken. The practices and policies which are the entirety of the Constitution Act of 1982 are not upheld in Canada. 100% verifiable and sitting in the hands of dozens of the top reporting agencies inside and outside of Canada. (O'Neill 2024) (AKA 'Is this Justice').

4. **Autobiography:** I Nancy O'Neill, (AKA 'Is this Justice'). Dedicate this Civil Suit to my Family of Irish, Maliseet and Cree Descent. Those living in the 6 Nations of Northern Alberta CA, under a Super Giant, 'Kee Tas Kee Now' Tribal Council in Treaty 8 Territory. These six bands are in need of immediate attention due to many of the leadership, who are ignorant, neglectful and or taking money off of their heads. Woodland Cree First Nation #474, Lubicon Lake First Nation #453, Loon River Cree First Nation # 476 (140 yrs. of heavy church involvement), Peerless & Trout First Nation #478, Whitefish Lake First Nation (Atikameg) #459.

Living and working directly with the students in Education on Woodstock First Nation Band #23 for 7 yrs., located in Woodstock NB, (the Peoples under 350 years of Imposed, Implied Colonization). My first marriage, my husband was beautiful on the outside and very broken within. He has Issues with substance abuse, this is to mask the Generational Trauma, it is unseen in facial features. Their actions under this applied trauma carries form one Generation



to the next. (The peoples living with unseen trauma cannot often control behaviors, especially with substance abuse). He did Verbally, Mentally & Emotionally abuse me under the Influence of Substances for our entire relationship. I don't have these types of traumas and or substance abuse and it is medically verifiable. With the abuse I sustained over this 7-year period, I developed a swearing habit I call it (GENERATIONAL TOURETTES), (O'Neill 2024) (AKA 'Is the Justice'). I swore in my home, like a 'DRUNKEN SAILOR,' as my present Common Law husband would say. My Ancestry is of Irish Decent and they sustained many Traumas under the Church & State and it continues today. I have been a hard-working lady who had trauma applied to my person. I was not introduced to this trauma until I was 23 yrs. old. It is very common in today's society and very predominant on the Reserves as it has been pushed on their People since Colonization began. For the First People and those in their bloodlines, when a person is undiagnosed and has multiple hidden traumas inside it becomes the main cause for substance, domestic and other abuses. When the Indian people were forced onto the Reserves, the crimes are easy to apply in isolated areas and absolutely horrific. I was not born into those types of Implied, Imposed Traumas so I can recognize them hidden, unseen & overlooked, 100% in all aspects of humanity. We (I mostly), raised Penelope Thomas for 10 years giving me hands-on experience with no assistance or supports provided. If I didn't make all the effort, she would NEVER of received her full Diagnosis: FASD: 3332 as per 4-digit code, Category K: which indicates SENTINEL PHYSICAL FINDINGS/STATIC ENCEPHALOPATHY (ALCOHOL EXPOSURE UNKNOWN). ADDH/ODD. Expressive language delay. (November 5<sup>th</sup>, 2014).

Raising a young child with multiple Brain Traumas, building a family, as a mother and full-time educator, was hard work. Yet I did everything to get Penny Diagnosed so she would have her chance at life. Then she was used against us, (ILLEGALLY). Living for 24 years inside of the Reserves, (First Nations Communities), I couldn't see all the hidden trauma clearly until KTC CFS placed it directly on my family July 7<sup>th</sup> & 9<sup>th</sup> (2020). The day(s) of the Illegal Apprehensions of our children. Now living outside the Reserve, once again, clarity has come back to me.

Additional teaching roles at South Tall Cree # 173 in Northern AB (1 yr. teaching multi grade level and part of the Peoples traditional practices. (The Reserves vary in number of years exposed to Colonization). After 150 years plus of imposed, implied colonization, forced removal of their children, breaking the people of the cultural, language, traditions & continuing applied forced displacement. (The Criminal Activity continues under the Canadian Government and the CROWN), historically, 'The Church & State!' An additional year of teaching at Little Buffalo School located at Lubicon Lake First Nation #453. (I, Ms. O'Neill carried my newborn with me to work for (4 months) as I was nursing and a strong team member and greatly needed for the junior high students! Most recently I have 16 yrs. of living, teaching, volunteering, a huge part of the WCFN community. Our four youngest children and my husband are band members. This community as well has been exposed to 150 yrs. of imposed, implied colonization!

Living in the First Nations for 24 yrs., 24 as a mother, 25 in education, 4 learning in multiple areas of the law. I have lived, learned and experienced the real truths of what is impacting the First Peoples of Canada! There is 'Active Genocide' full force in Northern AB and across the Country! Every First Nation Community is subject to the Genocide, 37 of the 44 Bands in Alberta have a Band Delegated Child & Family Services (Canada.ca). These organizations are an extension of the past Residential schools. Many First Peoples members live in fear of the Band Delegated CFS, Law Enforcement, Judiciary, & Medical the very genetics of the people continue to be altered. There is under and over diagnosed individuals. Very few receive the proper services as the money is bleed into Bureaucracy. Our case is confirmation of it all and heavily documented. As a mother and a human being, I cannot continue to be SILENCED, under the Canadian Government, the CROWN, its Institutions. Thousands are in fear, indoctrinated, living with unseen brain traumas, Generational with potential 'UTERO EXPOSURE UNKNOWN.'

The displacement in Canada continues, the brokenness for many of the First Peoples, (Indian), Inuit, Metis all-inclusive the Poor, Minority, Middle Class & now to include the Immigrants. The Government is still using Force to Displace the peoples of CA. In the Spring of the year, Arson implemented by

the Government is utilized to push the First People off of their Reserves and others from smaller communities into the larger towns and cities. (This is the preparation for the Global Agenda 2030) & used to distract the people. I was a candidate in the most recent Provincial Election. 100% Elections in AB/CANADA are bought and paid for with 'taxpayers' money on complete corruption. One of the largest 'ACTS OF DECEPTION' to Canadian Citizens, making us believe Elections are real. (O'Neill 2024) (AKA 'Is this Justice').

### **Who I continue to Represent.**

I am the Self Representative for the O'Neill-Thomas Family of Irish, Cree & Maliseet Decent. I will continue to be a voice for the children and Families on the 6 Reserves, (First Nations) under Kee Tas Kee Now Tribal Council and Services. All-inclusive every Canadian, the poor, minority, middle class & immigrants. Our case exposes, 'Active Genocide' in Canada and can be applied GLOBALLY. I am 'Above the Law' in my writings & findings. (No one can refute the EVIDENCE, 95% of it is their own CROWN Federal documents). As a mother of 5 Children, an Educator, Humanitarian, Advocate, Counsellor, Medicinal Healer, Peacekeeper, Legal Researcher, Document decoder of (Fraudulent Manipulation). All pertaining to CROWN, Child & Family, Legal, Medical, Law Enforcement, Insurance, Policy & Education documentation). Any forced signings; the Magna Carta June 15th 2015, The Doctrine of Discovery 1493 (mid fifteenth century), The Constitution Act of 1982, all-inclusive Law, Acts and/or Charters. I can address any and all, faulty, outdated, illegally implemented and upheld by the CROWN, 'JUDICIARY,' historically the 'Church & State.' We have been subject to 'Social Control' and massive deception by those in Authority in Canada, numerous World Leaders, Organizations, Institutions & Corporations. These entities hold contracts with Government on our heads, we are included without our say. They have committed Heinous Crimes against us and are to be considered 'Enemies of the Peoples' in Canada. This applies to other countries where they are still stripping their lands, resources and killing innocent children and families. Everything is driven by GREED & DECEPTION. All departments which are extensions of government, killing us slowly for their Power, Wealth & Control.

## 'Is this Justice! Shedding Light on a Fallen Democracy.'

### QUOTES: 2020-2024

- A) Feb. 2020, an Elder from (TREATY 6 Territory) took my interview, on what I felt was causing the pain, suffering and brokenness of the First Nations in Canada. I spoke for 40 mins and shared many references to the Residential schools and Colonization. When I finished, I asked him what are you going to do with that? " His response, "I am going to take that back to my Chiefs, you are going to save my People!"
- B) In August 2020, an Elder from Atikameg, (Whitefish Reserve in Treaty 8 Territory) did proceed to say to his daughter after our meeting, "I have hope, this white lady is going to help us!"
- C) In October 2020, I went to have a meeting with an Elder from British Columbia, he used to come to the school and work with my students, when I was in a Teaching Role in Cadotte Lake School. I shared with him what was happening to me and all the corruption I was uncovering. He looked at me and said, "my girl I'm not smiling because I think this is funny. I went to Residential School to meet you, because you are going to save my People." I listen to the Elders when they speak!
- D) In October 2020 a Counselor said in his Office at WCFN in the presence of another Band Counselor, my husband and myself. "Someone dropped a 'BOMB' on Loon Lake AB." Referring to me as I sent an email out to 172 recipients, at the time, all the Reporting Agencies I could find in Canada. (David Shin, the 'EVIL' delegated caseworker, said, "did you see the email she sent to Canada!")"
- E) Dec. 8<sup>th</sup> 2021, after 5 months into the Illegal Apprehension of our children, I pushed a so-called 'Case Conference,' (KTC CFS still in total BREACH of all POLICIES). I gave the Woodland Cree First Nation Chief and Council the push to take on their own CFS. At this

meeting WCFN Chief & Council signed a BCR to do just that. They would benefit as I pushed this out in 5 months, Chief Isaac Laboucan-Avriom said, it would take 2 years. (Like the Government Officials they would receive their cut right off the top, as soon as the ground was broken to build their new office for KTC CFS). All the while the Chief is supposed to sign for any child to be removed from the Reserve. Completely ignorant to what was even happening, paid thousands off of CFS every year, and \$1000.00 a day from KTC Education Authority. This Chief makes close to a million (+) who really knows a year with all the cuts, bonuses and bribes. Kept Absent from his people with the use of Marilyn Rudd the Band Manager (A PUPPET), used to blind the Chief & Council with money. At one-point WCFN had two people hired to do her job. (Unseen Brain Trauma, her Reserve Loon River (First Nation) with 140 years of heavy church involvement, multiple abuses of all sorts & (SILENCED). When the KTC CFS place children there, higher rates of SEXUAL ABUSE, have been reported through personal stories & (Hidden & SILENCED). Once a child is abused in any way, especially with all the IMPOSED, IMPLIED GENERATIONAL TRAUMA it leads to a life of continued hurt, pain, substance abuse and repeating the cycle for the next generation. Future generations become more broken than the last. The Trauma molding the people into more compliance, and willing to sell out their own peoples for monetary rewards. 🙏

F) After our meeting I returned to Cadotte Lake School, (Dec. 2020). I shared what happened with my principal at the time. She said, "Wow, you move mountains!" The Child and Family services control many aspects of the country and people on the Reserve live in 'FEAR' of them and all systems connected to them.

G) April 2021, MP Arnold Viersen did come to our home at the Reserve with his Assistant, Mr. Stardust on the words of a 'Catholic Priest.' That on the Reserve they were using the Child and Family Services, (Band Delegated) to 'Illegally Apprehend' the Children and that it is being supported by Law Enforcement the CROWN and others. Parents were Falsely being made Criminals

against their own children and families. This is included in the Schedule 1, inclusive with the other 2590 (plus) pgs. of supporting documents.

H) In October 2021, Father Joseph, of the St. Isadore Parish did say to me, “Nancy the people need someone to guide them, show them the way, someone like you.”

I) June 2021, Willian Thomas my father-in-law said when he was at the Treaty 8 meeting for their Chiefs. Artur Noskey the Grande Chief for Treaty 8, a ‘PLAYED PUPPET, BLINDED BY WEALTH and IMPLIED PRIVLEDGE.’ This Chief is very separated for the suffering in the Nations and is from Loon Lake Band. There is 140 years plus of the heavy Church Involvement. Chief Artur Noskey

future.

J) A young man in the Western Region of Uganda, lives in a Refugee Camp of 180 thousand people. Very poor living conditions in one of the richest countries in the WORLD! In our conversation he said, “since we started listening to you in Audio rooms, I see hope in my people!” (2023).

K) On July 21<sup>st</sup>, 2023 I had a large group of Christian Bikers, pray over me to bring Justice through my words for the People. I could never keep pushing forward without BELIEF & FAITH in the Great Spirit!

L) Father Joseph of the St. Isadore Parish did say to me in 2021, “you will have your children and be the Catalyst to tell the WORLD!”  
And that is exactly what I am going to do!

5. Excerpt from the Civil Suit Filing April 28<sup>th</sup>, 2022: With respect to our case, Crown vs. O’Neill/Thomas 2020-2024. There were Never

any professionals consulted, unless in KTC CFS favor, like Dr. Lloyd Flaro a psychologist, his office is located in (Stoney Plain, AB). He did with his assistants paint me as a monkey in a very **Unprofessional Report**. (The Report is Dated Jan. 13<sup>th</sup> and 14<sup>th</sup> 2021, a 'Parenting Assessment'). Introducing the corruption of Troy Janzen, the Complaints Director at the Alberta College of Psychologists, and the Deputy Registrar & Hearing Director, Aimee Brooks, (his Assistant). The Report was deemed an Official Complaint, by Troy Janzen in May of 2021. (I have his forged signature on that report). Amy Brooks 5 months later, sent a Report acting as Troy Janzen stating, "I changed my mind and it is in my opinion that." This is not a professional response under the complaints department Governing Rules and Regulations.

This is my 3<sup>rd</sup> complaint to the Alberta Ombudsman: (b) List any steps you have taken to try to resolve it and relevant dates. \* My (Nancy O'Neill) most recent complaints are with the United Nation and a Submission of Information to Special Procedures Report 'United Nations' Sept. 29<sup>th</sup> 2023 (2lkapyez) and a follow up Oct. 2, 2023 (plbdh7vf). I have submitted a third submission on Dec. 20<sup>th</sup> 2023 (gi0z3hju). (Both organizations are still in BREACH OF POLICY). If you are not quick with you submission it will be lost. I had to start over a few times. As well some of the most vital sections of the reporting template will kick you out and you will lose much of the information you have submitted. A very clever way to defer anyone from making a complaint. Very similar to the dozen plus complaints I have made to the top reporting Agencies in my Province & Country including Outside Entities.

### **My. (Nancy O'Neill) a section of a complaint to the Humans Rights Council. (2023)**

It is of the utmost importance as the lives of the alleged victim(s) continue to live under Section 12 of the Charter of Rights and Freedoms. The alleged victim(s), especially the parents were made to proceed as criminals in the Provincial Court of Peace River, Section 11(d) Under the Charter of rights and Freedoms. In High Prairie AB, this is where they initially remove the children and start the Action. Our children were hidden for 12 days with no known whereabouts, never separated from us in their lives. The children were only returned to the Reserve after they placed false Allegations on the parents with

the use of (PR RCMP & PR CROWN) and an ILLEGAL, 'No Contact Order'. Family and Criminal courts are both utilized to drain the families through two litigations, making parents criminals forcing them to obtain separate lawyers who follow the corruption only. The tactics and abuses create high levels of anxiety, PTSD, terrible Trauma imposed and implied by the Child and Family Band Delegated, RCMP, the CROWN, Family & Criminal Courts, Medical (Psychologists & Others). The Government, Federal and Provincial Ministers are (Neglectful and Ignorant), set on a high pedestal totally removed from the real suffering. Not one level of Government or Court is held accountable for their Laws, Policy and or Implementation there of. The Judicial was created only to uphold the corruption. Clearly prior to 2020 and full force during Covid 19 Lockdowns, closures and Mandates.

I have heavily documented Complaints to; the Minister of Justice office, Commander of K Division, Civilian Review & Complaints, Children's Advocacy, the Ethics Commissioner, Ombudsman, the Minister of Children's Services, (all ministers are figureheads), a complete farce & paid millions to wave at us, actors, all cost on civilians. The Victim Services, Local RCMP PR, and many officers who were involved and or brought in by Cst. Michelle Phillips. Who is now a Crp. and the true catalysts for the Illegal Apprehension of our children. Continuing to contact ministers within the country multiple times, Complaints Departments the College of Psychologists, Ministerial Review, Judicial Council for the Provincial Courts of Alberta Judges, The Canadian Judicial Council for Chief Justice Judges, and dozens more. I have documented this since June 6<sup>th</sup> 2020, the date the 911 CALL was made, and it was CLOSED AND DEEMED MALICIOUS THE NEXT DAY, JUNE 7<sup>th</sup> 2020. Our documents are filed in Peace River, High Prairie, Other Courts and are still being silenced). We were MADE CRIMINALS AGAINST OUR own FAMILY, ALL FABRICATED, a LIE built up to CREATE a TRIAL! Your own documents are used against you in the court of LAW. (Be careful what you say, it is all 'Script' a NARRATIVE so they can confuse you, make you look guilty, very ILLEGAL! The systems stall, bully, ignore, and bleed you of your money. IN CANADA, YOU ARE GUILTY UNTIL PROVEN INNOCENT! Section 11(d) under the Charter of Rights and Freedoms, 100% VERIFIABLE IN ALL MY FILED DOCUMENTS & FINDINGS. The 'Rule of Law' is not being upheld in Canada it is UNCONSTITUTIONAL! The Rights of the Children, Parents, the Basic Securities under the Law, are being deprived by the Judicial, Governmental, Law enforcement, Medical & the Institutions. No one is monitoring the corruption embedded within the systems that are based on inflated POLICIES, which only apply after the laws are broken against the persons and families. The very development of the courts is a complete hidden lie in Canada. Out of the Federal, Provincial, and its

institutions, (THE LARGEST CRIMINALS IN CANADIAN HISTORY TO DATE ARE 'DELEGATED AND NON-DELEGATED CHILD AND FAMILY SERVICE. When they break the children at young ages it does create a lifelong clientele. The Parents, children, Kokum's, Mushom's (grandparents), sisters, aunts, uncles, everyone connected to that child will feel the Impacts for Generations. This is most predominant for the First People the (Indians), Inuit & Metis as the Traumas are present in their bloodlines and the impacts vary according to years of exposure by the Government and its systems. (O'Neill 2024) ('Is this Justice').

No Law is upheld when it comes to the Child & Family Services, they are still utilizing 'Birth Alerts.' Young women alone cannot protect themselves directly after the birth of their child, this is very predominant for the First People in the 'White' hospitals and is done for \$\$\$\$. They continue to Break Policies, not uphold Bill C92, the Child Intervention Framework there was 18 Charter breaches against my Indian, (Indigenous) family in 2.6 yrs. Every matter upheld by the Judges, Lawyers, Court Clerks, Assistants at various levels. The Ministers offices, the Appeals Secretariat there are (5 persons named), Victim Services, Children's Advocacy, Minister of Justice office, The Law Society, MP Arnold Viersen a Psychologist Lloyd Flaro, still not held accountable for his crimes against my family. (Flaro's reports DEPRIVING the Children and Families of normal life ever again, over 35 yrs. in operation. His office is located in Stony Plain AB. Dr. Lloyd Flaro is listed for Edmonton's Child and Family services as well. Known to make \$ 600,000.00 a year off of KTC CFS. (Disclosed to me (Ms. O'Neill) Dec. 2020 by Lawyer Harry Jong of HP, AB 35 yrs. in practice. Thus, continuing the Genocide; Stolen souls, culture, language, molestation, rape, beaten, murdered, missing, under KTC Tribal Council, services and affiliates. (Thousands are suffering this right now from Illegal Apprehensions of the children, False Incarcerations, Medical Misdiagnosis &

Underdiagnosis. These Imposed Traumas continue to increase the impacts of Generational Traumas on the children and Families under KTC Tribal Council, services & (Country Wide). The crimes taking place against Canadian's have many moving parts. The most recent, 'Covid 19', open acceptable support for Pedophiles, forcing confusion on under age children. (The Carbon Scam for Climate Action. The fires are set by the gov. to destroy communities and move forward on AGENDA 2030. (Where is the money going?) (Billions in War Aide STOLEN from Canadians & (OTHERS).

**7. Excerpt from Civil Suit # 2209 00038 (Filed April 28th, 2022): The Persons in connections to the Crimes stated here within; in the Private & Public Federal Institutions, Federal Public Servant(s), A Band Delegated (KTC CFS), there are lots of people employed with undiagnosed Generational Trauma. (It is Unseen in their faces but it shows through their actions). The 'Commander of K Division,' (Curtis Zablocki) his office is located in (EDM, AB and in 2021, when I was sending out massive complaints, Mr. Zablocki a 31-year veteran with the RCMP and still in breach of Policy, he is simply a figurehead with no accountability only entitlement. The RCMP Officers in PR, HP & Red Earth, AB). The Civilian Review and Complaints the head office is located in Ottawa). Many of the top reporting agencies are in Ottawa, giving them control to stop anyone who threatens their existence. An Investigative officer Retired from service of 43 years with the (RCMP), Judges in the (Family, Criminal & Civil areas) are kept away from the entire situation, at times, its (ILLEGAL). In (HP, PR, GP), the Crown Prosecutors (PR), Lawyers in (EDM, GP, PR & HP). The Multiple Health care Professionals (EDM, PR & HP). Individuals in the 6 Nations have and continue to share stories of 'Illegal Apprehensions and False Allegations' instilling fears by the Nurses at the hospitals in (PR & HP, AB). The Federal Government Reporting agencies. An Edmonton City Police Officer at the (Central Office Detachment, he came out and viewed my materials and stated that officers lie about 911 calls all the time. I couldn't talk with the captain he said he was in another building and doesn't talk with civilians. All the Ministers Offices are (Figureheads with IMPLIED PRIVILEGE), and are removed from the corruption. It takes place**

through their Assistants and (Others). I purpose Mental Competency for government officials, CEO's, Directors the list is extensive. Are these Ministers, (Government), capable of anything but acting out the scripts they are provided? (Thousands of people are doing the jobs for Politicians across the country and we are paying for it). They are of direct Lineage or having Entitlement through Royal Descent, in connection to the Monarchy. Hence why so many positions are appointed and or delegated in the Government. The Federal Government has implemented the same form of governance on the Reserves. This allows them to pull in Millions on Salaries, Bonuses, Honorariums and Bribes taken before it ever reaches the people. A mirror reflection as to what is happening under our government in Canada.

There is no sympathy for the people? (The Covid 19 Lockdowns and Mandates), while Canadian's were locked down the politicians moved around freely and went on vacations. When they returned, they were placed in luxurious hotels, the cost on taxpayers, thousands of dollars for 2 weeks. Thousands of Canadians lost their jobs because they wouldn't force Vaccinate. How many Canadians' lost loves ones because of the vaccinations and locking our Elders in nursing homes to die scared, sad and alone through the 'Covid 19 Genocide.' This is being 'Silenced Globally'.

## **8. Judiciary/Alberta Courts Website**

The Alberta Courts Website (2022) was openly deceiving the Public. Civilians are led to believe they can self-represent, 'Fairly and Equitably.' This is not the case. Trying to file as a Civilian on any computer, it took me 8 different ones to open their 'Archaic Operating System.' Luckily, I was directed to the 'Lawyer's Forms directly underneath. They are 'Immaculate,' very easy to use, and would open anywhere in the country. 'You are forced to get a Lawyer!' After I called this out in my first Civil Suit 04/28/2022., Alberta Courts Website was handed over to the Justice Department. I discovered they made it even more difficult to file as a Self-Representative. This is Illegal use of Taxpayers money by the Justice department, deception under the so-called Democratic Monarchy. **We have been lied to our whole lives, fed a NARRATIVE. Those in power make up 1% of the Population, driven by**

**GREED & TYRANNY! Individuals who work in Additional Organizations are used to protect the Government, (shelter them/separate them) from persecution for their crimes against the people. There is a very good reason for the different levels of Courts, the lower courts stall you, defer you, take your money, energy, family & possessions. There is no such thing as a fair, just trial or movement through the courts. (100% verifiable) that Civilians are stalled on every level, hence why no one chooses to keep trying to find help). (The Law Society, Ombudsman, Civilian Review and Complaints, the Appeals Secretariat are all Controlled & Corrupted by the System).**

**There is massive Incompetence Levels for those Individuals who are Delegated & Appointed within the Reserves. (Nepotism and Brain Trauma- is very predominant for many thus they destroy their own communities for money). 75% (+) of the children in care in Canada are of Indigenous descent). (QUOTA) (A comment form one of the 5 Chiefs in the 6 Nations (Atikameg, AB) 2020. All based on \$\$\$\$\$\$.**

**If you are of the First People (Indian) almost everyone you know has a direct connection to, a Residential School Survivor, 60 Scoop Survivor, know of many Murdered, Missing, victims of Rape, Prostitution, Substance Abuse, Homelessness, Poverty, Molestation and with Unseen (Brain Trauma). The Child and Family Services, with the Church and State all connected to the Monarchy, the (CROWN) have never ended only masked what they have continued to inflict on the First People and clearly others in Canada. The governments keep getting greedier, needing massive amounts of money to cover their elaborate spending. The Hierarchy positions, control the Masses with the cruelest unbearable treatment to the innocent Peoples of Canada.**

**I. (Nancy O'Neill) have included additional notes with respect to the courts and documents. Since my last filing the font is now smaller, in areas where they should be clear. The Clerks manipulate everything to make it hard to read and try to make excuses as why not to file you documents. They want to keep the file clean of evidence against them. When I have filed major documents, they have altered the format, blurred them, darkened them in numerous ways. Playing with page numbers, using a fax machine to copy documents.**

tampering with evidence, creating a false narrative on any one they choose. All the rules are broken to pull in innocent people and no rules are followed unless they are called to task. The Canadian courts and systems are very corrupt and operating MALICIOUSLY. I am so confident in my findings that I can apply this in any country of the world. (The documents speak for themselves).

You are forced to serve your attackers in any way you can or pay \$\$\$\$ for a Process Server and or Lawyer. It is made difficult for anyone but them to move the court case forward. This is all part of the THEATRE. The Gladue Report, is based on \$\$\$ and controlled. The Gladue Writer has to hand it in to the court to have it proofread and they can change what they want. I made sure to send them their needed corrections. All courts get to decide in Canada whether or not to hear a case. That is why the Supreme Court will only hear the cases with the largest profit to be made. This means more money for the stakeholders. Nothing goes through the court unless money is attached to it. During Covid 19 their budget went up in the billions per year.

The Department of Justice Canada's total planned spending for 2022-23 is \$921.8 million:

- \$219.1 million for Legal Services (24%)
- \$621.3 million for Justice System Support (67%)
- \$81.4 million for Internal Services (9%)

The Government of Canada - we can't feed, house or provide proper services, but we will, SPY, FALSELY INCARCERATE, RAPE, BEAT, STEAL & TRAFFIC CHILDREN to keep the cycle going. As well we will hire all of our family members and live a good life off the misery inflicted on others.

9. Excerpt from the PR CROWN DISCLOSURE, our Civil Suit # 2209 00038 (Filed April 28th, 2022): The Judicial & Federal Complaint Intuitions with the Civil Servants who did, create and mislead the reader with false evidence. The materials were placed out of order and Context. The documents provided were doubled, tripled and implied the

**perception that there is substance with quantity not quality. (The Undertaking Promesse was served the day before we got to see our children, intentionally to keep us as 'PRISONERS,' from them). (The No Contact clause was put in place only before they brought our children back to the Reservation, (in Breach of Bill C92), This Undertaking was never signed off, a tampered one was later to be introduced, completely illegal. It was supposed to be signed by a Judge and a copy provided to us. (We were signed forced to sign July 23<sup>rd</sup> 2020 & the Informant did not sign until Aug. 21<sup>st</sup> 2020. The New Allegations were added and it was never served on us. The Original was never signed off ever).**

**As our time moved closer to trial, there would be more falsified Crown Documents, tampering of evidence, bullying, stalling, misleading, emails showing unprofessional conduct by the Lawyers. A Judge, the Directors Lawyer, Advocate Lawyer, a Family Lawyer excusing a Summary Hearing on Sept. 23<sup>rd</sup> 2020 in High Prairie AB. (This Court was held out of Jurisdiction on Feb. 26<sup>th</sup> 2021 (PR AB). There is no clear support for Civilians, the Lawyers are not providing correct information. (In breach of their own Governing, Laws, Regulations, Policies and Procedures. There was no movement in any court until I started Reporting to Canada and firing the lawyers.**

**10. Excerpt Civil Suit # 2209 00038 (Filed April 28th, 2022): The Enactment of the 'PLAN,' 4 months into the Covid19 lockdowns my 4 children and one step child were 'illegally apprehended' by the Band Delegated Kee Tas Kee Now CFS & with the assistance from the PR RCMP. Our entire case is run on double dockets (#'s) and on a CLOSED INVESTIGATION # 990227 it was OPENED June 6th 2020 @ 19:00:00 and CLOSED June 7<sup>th</sup> 2020 @ 21:00: 00 and DEEMED Malicious by CST. Shin Kim, PR AB Detachment. (This number was to be ILLEGALLY replaced with a second investigation # 5 months later # 995227. There were 18 Charter Infringements placed upon my husband and children of (INDIAN) Indigenous descent in 2.4 years. The illegal apprehension took place at Woodland Cree First Nation #474. (Our children lived and schooled full time in PR AB since 2016 and it was completely ignored).**

Our children had to return to the Nation during the Covid 19 Lockdowns. I was the lead in the Cadotte Lake school. Alone performing multiple roles for KTC Education Authority, 5 years my employer. (I have lived 16 yrs. in this community, 25 in education, 24 living in First Nation communities and now 24 a mother of 5, never any involvement with the CFS. There was a 'PLAN' in motion for 1 yr. very clearly laid out within my findings. All subject matter is illegally being silenced by the courts in PR, HP, EDM & GP, AB. By Removing the hired lawyers and acting as a Self-Representative for my Children & Family, I was able to reunite us under a 'Private Guardianship,' initiated October 8<sup>th</sup> 2021 under the Direction of Judge R. Marceau in PR. This was his second time sitting out of Court Jurisdiction, the Prior sitting was Feb. 26<sup>th</sup> 2021. There is no one upholding the law within any organization or institution connected to Kee Tas Kee Now Tribal Council & Services. The Services bleed the Nations people of their entitlements and they live in fear of KTC CFS, the RCMP, the Courts and Medical Services. The list is extensive, my findings hold over 100 plus names, dozens of institutions, up to our Trial on Oct.17<sup>th</sup> - 22<sup>nd</sup> 2022 and including up to, the present day. The files are documented in CanLII. I have continued to Report to numerous agencies and institutions to seek Justice for my family, the 6 First Nation Communities in Treaty 8 Territory & now (Others) in Canada! The Judiciary System was put in place to control all movements of Society and it is ILLEGAL. Judges are Appointed and paid by the Federal Government, hence why nothing enters the court unless there is a monetary value attached. The courts function on Power, control & dollar amounts, NOT the 'Rule of Law.' (O'Neill 2024) (AKA 'Is this Justice').

As Our family was being tortured, Penelope Thomas and her two sisters were being placed with the Maternal Grandmother. Linda Collins she is a 60 Scoop Survivor, in her younger years a known Prostitute, has 2<sup>nd</sup> Generation Utero Exposure Unknown, 150 years of implied Generational Trauma and a Veteran in the Child Welfare System. She was now able to collect the money from the system whereas Penelope Thomas is fully Diagnosed WITH MULTIPLE BRAIN TRAUMAS. Penny did become the babysitter for her younger sister Ziya. It was stated within the evidence & Linda Collins



(Courtorielle) was a huge part of the 'PLAN,' and well known and or related to individuals in the KTC CFS office in (Loon Lake AB). (Everyone is related)!

The Band Delegated Child and Family Services replaced the 'RESIDENTIAL SCHOOLS,' the Tribal Council Directors took the place of the 'Indian Agent & the Priest.' Under the Federal Government the 'CROWN,' the (Church & State) they own Canada. The First Peoples (Indian), Metis, Inuit and all-inclusive the Poor, Minority, Middle Class & Immigrants are under complete control. We are simply commodities to the government to be bought and sold. The Indian, (Indigenous) were here first, the continued Imposed, Implied Sanctions increase the IMPACTS of Generational Trauma leading to higher rates of UTERO Exposure Unknown. A Life sentence of struggle, severe for many. The unseen Brain Trauma brings more substance abuse and the negative impacts become greater with every generation. (O'Neill 2024) (AKA 'Is this Justice').

**11. The Band Delegated Child & Family Services all-inclusive Peace River/Other Child & Family Services are corrupt across Canada & Globally.**

**Excerpt Civil Suit # 2209 00038 (Filed April 28th, 2022):**

All intuitions involved have Broken Policies and Procedures: the 'Alberta Child Intervention Framework, Bill C92 and others inclusive.' (Cst. Michelle Phillips with the (PR RCMP), was the 'CATALYST,' for our 4 Biological Children to be removed, 'ILLEGALLY,' and a child with womb induced, 4<sup>th</sup> Generation Brain Traumas.' (Penelope Thomas was removed July 7th, 2020 at the (PR, RCMP, Office by KTC CFS with no exchange of paperwork. We were told it was Arlene's parenting time and a Further Investigation to follow, our Investigation was closed one month earlier). Our children were removed from the Reserve WCFN, July 9<sup>th</sup> 2020. The Led Interviews, in written form placed in the Crown Disclosure, all documents are stalled, the RCMP & the CROWN will defend CFS tooth and nail. This brings more bonuses for the corruption and lifelong clientele that comes from the breaking the innocent in society. The 600-page disclosure was manipulated by? Potentially there are

dozens involved, this is inside training for the corrupt; officers, court clerks, paralegals, supporting institutions for the First People. Many office Assistants, KTC CFS Delegated Caseworkers & Other(s) outside assisting (KTC CFS), with their falsified, misleading information on our closed Investigation #990227. (At our supposed Case Conference 5 months after they Illegally Apprehended our children), WCFN 'Chief and Council,' signed a BCR to take back their own, 'Child and Family Services,' yet we were still being held as, 'Prisoners from our Children.'

Within the (KTC CFS Disclosure), this document was quadrupled and contained a 'Docket,' on, 'Arlene Courtorielle with (3rd Generation UTERO Exposure UNKNOWN), a (Domestic Dispute (Dated), 2015/12/30). There is nothing to show that our children were abused unless put there by Cst. Michelle Phillips and or the author(s) Misleading the Audience, Deceiving the Reader, if they even look at it. In the courts the message is pushed that Quantity supersedes Quality, not in the real world. There are potentially 30 plus people involved in falsifying documents on several levels, the documents speak volumes and cannot be denied. (The entire case is based on falsehoods, women with Criminal Records, MALICIOUS INTENT and their 3 children all with unseen substantial BRAIN TRAUMAS. Stemming from Generational and UTERO Exposure UNKNOWN. The only one fully Diagnosed Nov. 5th 2014 with Multiple Brain Traumas & excess 4<sup>th</sup> Generational UTERO Exposure UNKNOWN, my step child and Ernie Thomas's Bio child. Without us raising her for 10 yrs. and having her full Diagnosis for 4 yrs., at the time when the 'PLAN' was enacted June 2020. Penny's physical age was 11.5 yrs. and her 'COGNITIVE AGE' was 4 to 6 yrs. old, (medically verifiable). The Trail was not held until 2 years after that. Penny would not have been able to be the CROWNS 'Star Witness', unless coached, she loved us and followed me everywhere. Yet hated rules, played the victim with her mother and Aunty Lynn. Both women not fit to make adequate parenting decisions. The medicine used to calm Penny is what helped her to learn. (Her Full Medical Diagnosis-FASD, ODD, ADDH & Severe Expressive Language)- If they could have just waited until she was 12, Ernie was going to let her choose where she wanted to live. Penny needs to be placed in a home that can raise her

according to her high needs or she will live the lifestyle of her mother & grandmother. (Heavy drugs use, alcohol addictions, prostitution, theft and homelessness).

**12. Excerpt Civil Suit # 2209 00038 (Filed April 28th, 2022):**

**The Civilians involved, were incredible initiators, 'Criminals with Intent and Motive,' Substance Abuse, (Coached and guided children with womb induced, 'BRAIN and GENERATIOANL TRAUMAS'). Many people were involved, to help create an elaborate, 'PLAN,' of child Abuse in our home at (WCFN). The 'PLAN,' in motion for 1 year stated by, 'Lynn Thomas to her Father William Thomas,' June 10<sup>th</sup> 2020. Lynn was arrested that day by Officer Dan Kirwan in breach of another warrant. The 911 call made by Lynn Thomas and was deemed MALICIOUS by (CST. Shin Kim) the next day, June 7<sup>th</sup> 2020). There were falsified statements created over a year period. This is common for CFS, very immaculate for the amount of, 'Brain Impairments,' present in the civilians involved in this case. (Unseen & undiagnosed Brain Trauma is very rampant on the Reserves in Canada).**

**13. 10 years of raising a child with multiple Brain Traumas, 5 yrs. dealing directly with FASD and other support services for Penny. Gave me hands on experience that many people cannot afford and or deal with easily. Your whole family gets put aside to meet the needs of one extremely high needs child. I took her to all her appointments. I have 24 years extensive involvement in First Nation Schools. My last 5 years in Education, as a Counselor and Inclusive Ed. Lead. In this role I was the Support for the FASD, Speech & Language, Autism, Hearing Impairment, Physical Disability, Undiagnosed Brain Trauma, UTERO & Generational. I was the network and connection, for all the children and families at WCFN.**

**The unseen & undiagnosed brain trauma carries negative impacts and is very detrimental to a person's life functioning and achievements. Individuals with exposure to Generational and Utero Trauma are not fit to testify in the court of law without a proper professional to administer**

**the questioning. Thousands of Indian, (the First People) are in jails, homeless, living in poverty, higher rates of suicide, addictions, PTSD, under diagnosed, over diagnosed with imposed, implied mental conditions. 'All Services' are fed a Narrative about the First People and it does impose negative outcomes. A privileged person who has never suffered cannot identify with someone who was born under many generations of applied traumas. The Medical General Practitioners, Psychological, Psychiatric, Labeling, Miss Diagnosing, Imposing/Implying Addictions, Implying/Imposing Mental Incompetency, Falsified Medical Reports, & Falsified Psychological Reports. This does constitute crimes against the First People and Others in Canada. Once they place a label on a person it follows them for life.**

**Millions of people are living under Implied Trauma by the Gov. and Systems. We are led to believe that everything is in place to support us. The real truth is we are being slaughtered to meet the needs of their growing families and their GREED. To uphold the sick practices placed in society by the Original, 'Founding Fathers,' which I refer to as the 'Pedophile Fathers.' All problems in Society can be linked to those who conquered, stole, imposed, implied TYRANNY on the Peoples across Canada and the Globe.**

**The Medical field draws billions of dollars each year and is completely unmonitored. The Psychologists and Psychiatrists are highly favored as they are used to make people 'CRAZY,' keeping the families separated for the CFS and the Family & Criminal courts. The practices are very intrusive with negative impacts lasting forever. All cases vary from person to person, and are horrific especially to the First People of Canada born and raised on the Reserves. The Indian the (First people), Inuit & Metis receive the least number of services, followed by the Poor, Minority, Middle Class and all-inclusive the Immigrants.**

**The governments take all 'Patents' and keep them hidden for their own benefit and personal gain. We are guinea pigs to them, hence the Covid 19 Vaccinations, lockdowns, mandates and the body mutilation being**

forced on children and families. As Canadian Citizens we deserve the least intrusive medical advancements. The current medical and health care systems are making people suffer for the Big Pharmaceutical Companies to rake in billions off of the imposed, implied suffering.

### Remedy sought:

We Authoritatively Demand, Immediate Calls to Action for Canadians suffering under the CROWN, the Church & State. THE ISSUES IMPACTING HUMANITY CAN BEEN RESOLVED WITH A ROUND TABLE OF PEOPLE, WHO CHOOSE TO UPHOLD FREEDOM, JUSTICE & WITH TRUE INTENTIONS, NOT ONES OF GREED & TYRANNY.

It is very vital that I take the best care of my family as possible. I ensure to help rectify any unjust taking place against the Children, Families my Brothers & Sisters living under the Governance of Kee Tas Kee Now Tribal Council & All Services, in Treaty 8 Territory. With the use of the Neglectful Leaders, Judges, Lawyers & Directors, those in positions of power very separated from the suffering. Individuals raised with Implied/indoctrinated Privilege, Negligence, Ignorance, Social Control, No Accountability and paid very heavily for their CRIMES against the Peoples, the Indian (the First People) and Others. Where is the Justice? 98% of these names are carried from my Civil Suit, Filed April 28<sup>th</sup> 2022. #2209 00038. Illegal 'Quashed' June 10<sup>th</sup> 2022.' (Never to be seen by a Chief Justice very illegal actions are happening under the Judiciary). (O'Neill 2024) (AKA 'Is this Justice').

The Judges: The Honorable G.W. Paul in (HP) Starts the Action, The Honorable D.R. Shynkar, he jumps around to cover for the others in (HP & PR). The Honorable Judge R.B Marceau, was out of court Jurisdiction twice in (PR). The Honorable Judge Andrea Chrenek in (HP), wouldn't not allow me into the courtroom and made me believe she gave my children up to KTC CFS on a 'Permanent Guardianship Order.' (No one even knew the date they illegally apprehended them). Do you have any idea what it feels like to have your children Illegally taken from you and think you lost them forever twice? All I could do is keep fighting back. The Honourable Judge Claus Karl Willi Thietke, did force us to proceed as 'CRIMINALS,' in his

courtroom. He bullied me, allowed for the court processes to be ignored, was our trial judge and signed Penny off on a PGO to Peace River Child and Family Services August 25th, 2022 very (ILLEGAL). The Director's Lawyer, Jeff Harcourt twice in open court said, "Mr. Ernie Thomas is not present." Ernie had to speak up as this was happening on ILLEGAL PRETENCES. I had to sneak Ernie back from his work 3 hrs. away into this court setting. They wanted it to be clean because Judge Thietke was playing both courts and it's ILLEGAL. The Honourable Hougestol, he bullied me, told me to get a lawyer and was out of Court Jurisdiction on Aug 8, 2022 PR AB. The Honourable Steven P. Hinkley, (he was sent to bully me and was out of Court Jurisdiction Aug. 29th, 2022 PR AB). That day in Docket Court, Mr. Thomas moved me, Nancy O'Neill in the front of the microphone. Ernie said, "I think he will hear you better." How ironic a long-haired Indian supporting his wife in a racist courtroom, us there on ILLEGAL pretences. I said, "we are here on a CLOSED INVESTIGATION # 990227." Judge Hinkley, dropped his head on the Bench as this was being recorded. He was sent to cover for Judge Marceau who was out of court Jurisdiction X2. (Now the King of Courts Bench the Chief Justice K.G. Nielsen who never received any of my documents, nor did Chief Justice Derek Redman. Both separated from the involvement and IGNORANT as to what is happening under their names very (ILLEGAL).

The Honorable David Lametti (Minister of Justice and Attorney General of Canada). There have been 3 Ministers in this position since 2020. Kacee Madeau & Arif Viriani (presently), they answer to the Prime Minister and can hold the position for as long as the King desires. There is NO ACCOUNTIBLY to CANADIANS. (Nothing but a Figurehead). Paid lots of \$\$\$\$\$ for the Portfolios he holds and he holds Complete Allegiance to the King! (The CROWN).

The Crown Prosecutors: Naveen Powers, Mark Mastel, PR (Head CROWN Prosecution), Bruce Ritter, Sheldon Ostopowich, he covered for the Veteran CP Bruce Ritter, (Jan 30th 2023 for an Illegal Court Date that I made happen. They are still trying to cover it)! The Original Verdict was Dec. 19th 2022. I'm too smart for them and they know it. So, they play hardball theater. On one occasion they had the courtroom filled, there were sick people coughing behind me, Thietke would call out a hundred names, a row of guards with big guns, body armor and a 'PRISONER' all in 'Docket Court' to 'SCARE' me. Usually, I had to sit through this all day. Learning about the courts. I should have well over 100 plus hours in the court sittings since July of 2020.

The Lawyers: Ross Brooks, (the Director's Lawyer for KTC CFS 'EVIL'). Natalia Reiman the Advocate Lawyer, very 'Evil', Lola Antonius (she keeps you in HP court), Harry Jong 35 yrs. in practice, Chuck Dimiri, Micheal Sparks, Kyle Procee,

Kristy Broadhead & Jeff Harcourt (the Directors Lawyer for PR CFS very 'EVIL'). A few others, Catlyn Dick, Holly Spurrel, Luc Certa, (my Severance Lawyer). Much of the corruption is done through the Paralegals and other assistance. (Dr. Lloyd Flaro, in practice for 35 yrs. and my Lawyer Harry Jong as well (35 yrs. in practice) he said, "they sent you to him he doesn't find anyone COMPETENT)." Including me, Nancy O'Neill an Educator of 25 yrs. (This Psychologist keeps the children and families separated in the Courts). His Reports deserve a Grade of 'F,' or whoever is writing them with his title, is why he makes the money.

The CEO Al Rollins of Kee Tas Kee Now Tribal Council was a former Lawyer pulling in over \$ 1 million a year as a figurehead of off KTC Tribal Council, 27 years of operation. (He was hired to help the people, not a chance. He became a millionaire and is still bleeding those Nations to death). He's there for life!

These next few in positions of Leadership, 100% never and or underdiagnosed Generational Brain Trauma, unseen (with potential UTERO Exposure UNKNOWN). These individuals have Implied Privilege and are separated from their people, blinded by money. Their parents would have been very 'COMPLIANT' in Residential School. Hence why Indians, (the First People), will sell out their own family members. This is very predominant and was forced on any race that was conquered by colonization. You are rewarded for being compliant and PUNISHED when you stand up for yourself. On the Reserves you are bullied and controlled by every aspect of their colonial governance.

These 3 Chiefs sold their people out at KTC CFS Board Level for \$\$\$\$\$\$\$\$\$.

Chief Isaac Laboucan-Avriom Woodland Cree First Nation (# 474)

Chief Ivan Sawan Loon River Cree First Nation Band (Loon Lake # 235)

Former Chief Gladys Okemow of Peerless & Trout First Nation (# 478)

Mona Auger The (Delegated) Director of KTC CFS (A 'PUPPET' with Implied Privilege), used to blind the Chiefs with \$\$\$. She has no accountability and Undiagnosed Generational and potential Utero Exposure Unknown Traumas.

Irene Bellcourt was a Supervisor for KTC CFS and now WCFN CFS. (She is 'Evil' and all about the money, another (PUPPET). Her best feature is Apprehending Children, destroying families and she thinks she's a queen. (People with undiagnosed Trauma cannot see themselves for who they really are). Pearl Calahasen the Assistant Superintendent of KTCEA, (Implied Privilege a former MLA, who continues to sell out her communities out for \$\$\$\$). Stealing off the heads of the Children & Families, (EVIL with Implied Privilege).

**Marilyn Rudd the Band Manager** at WCFN, (Implied Privilege) & (Undiagnosed Trauma with 140 years of the Church involvement in her community of Loon Lake (Band AB). (She would do anything for MONEY). No concern for anyone but her immediate family and friends. 100% she is used to keep the Chief and Council separate from their people. 'A PUPPET for \$\$\$.' She has people doing her job all the time. Is unable to draft a formal letter without Assistance.
